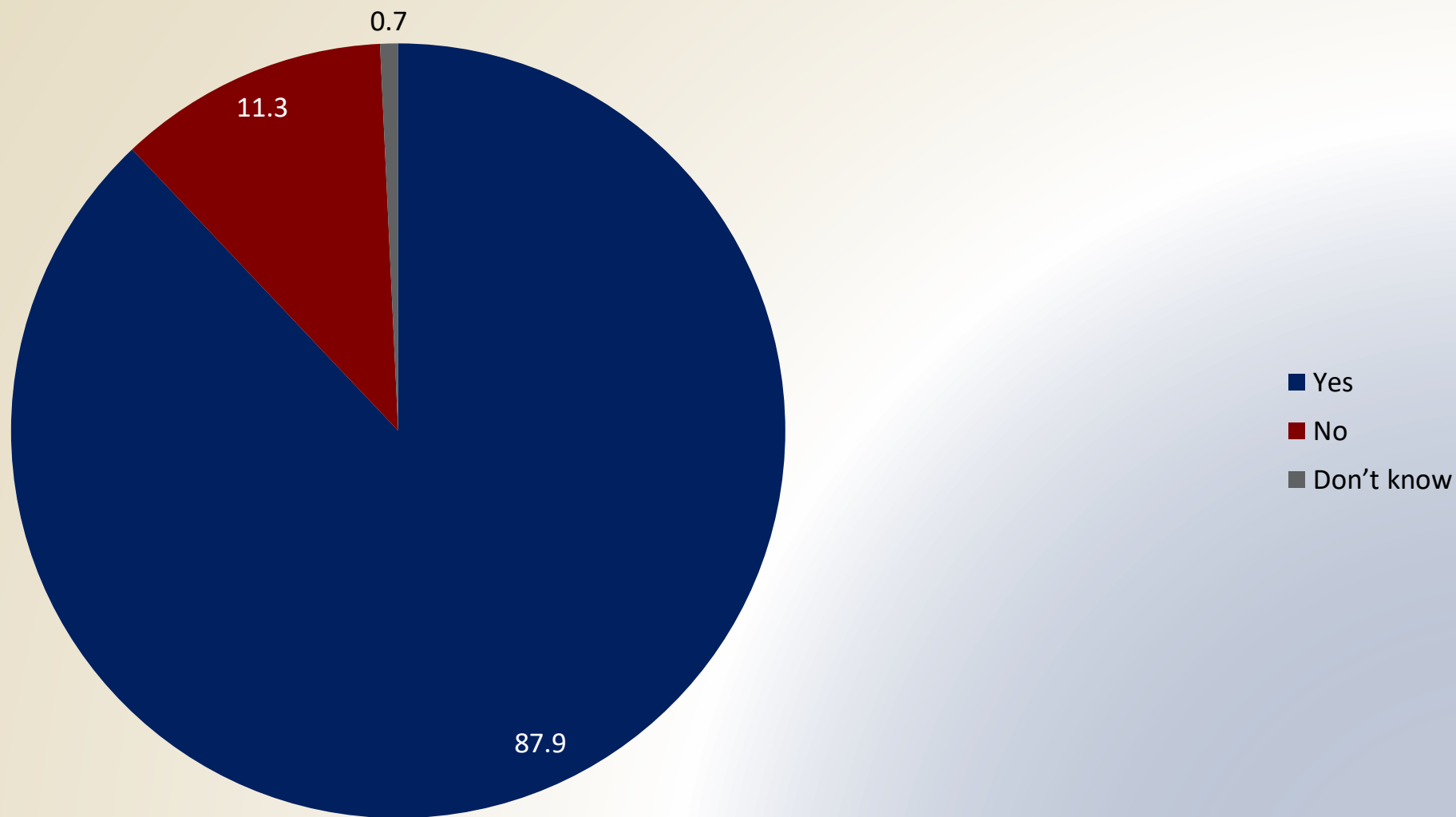
This Survey

- The poll was conducted between August 22 – 30 2023.
- It covered a sample comprising of 1,202 Jordanians.
- The marginal error is 3% and the confidence level is 95%.
- 28 enumerators have collected data for this survey.
- 7 field observers were present to monitor data collection.
- The supervisor monitored the data collection and ensured the implementation of quality assurance measures.
- There are two functions specifically assigned to the data analysis team. They simultaneously handle the statistical analysis of the multiple-choice questions in addition to the coding and analysis of the open-ended answers through statistical analysis software such as SPSS & CPro.



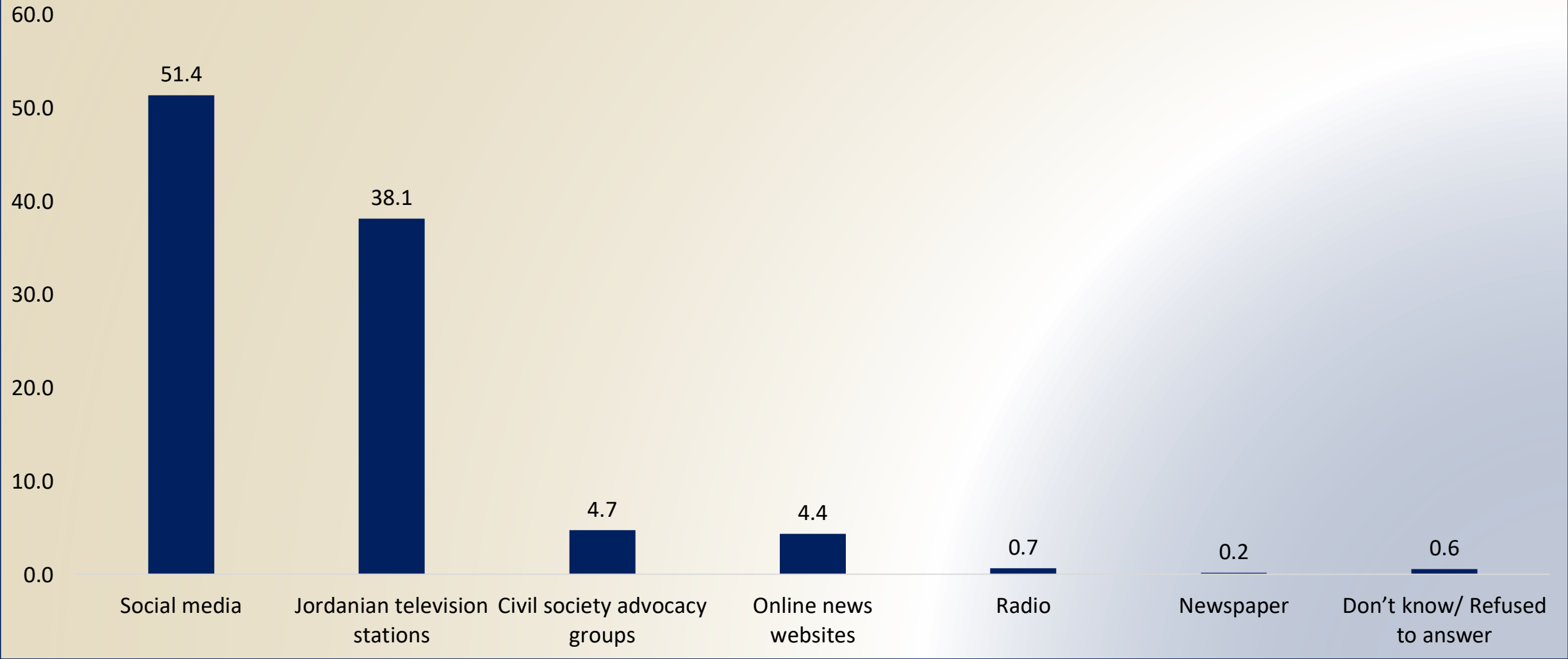

What is the main source that you have heard about this cybercrimes law through?

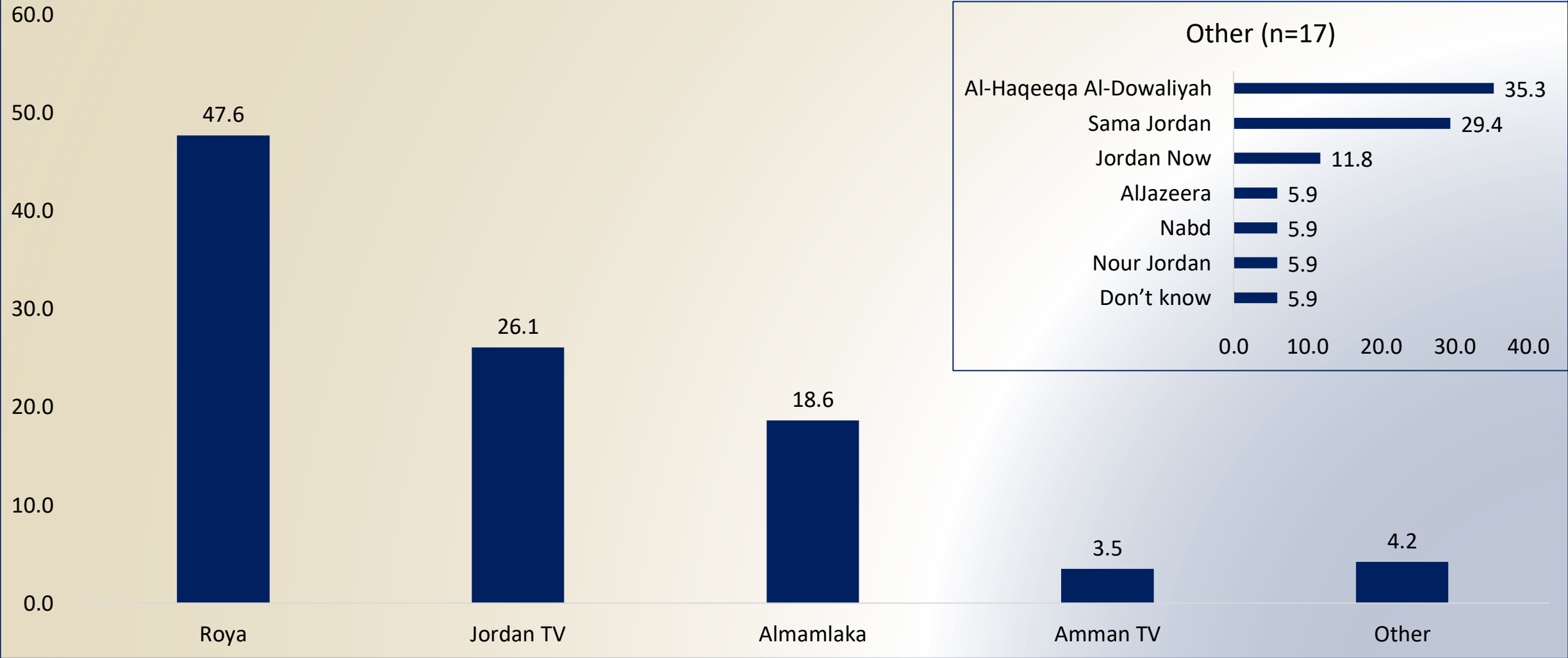
Of those who indicated they heard about the new cybercrimes law

Please name the TV channel?

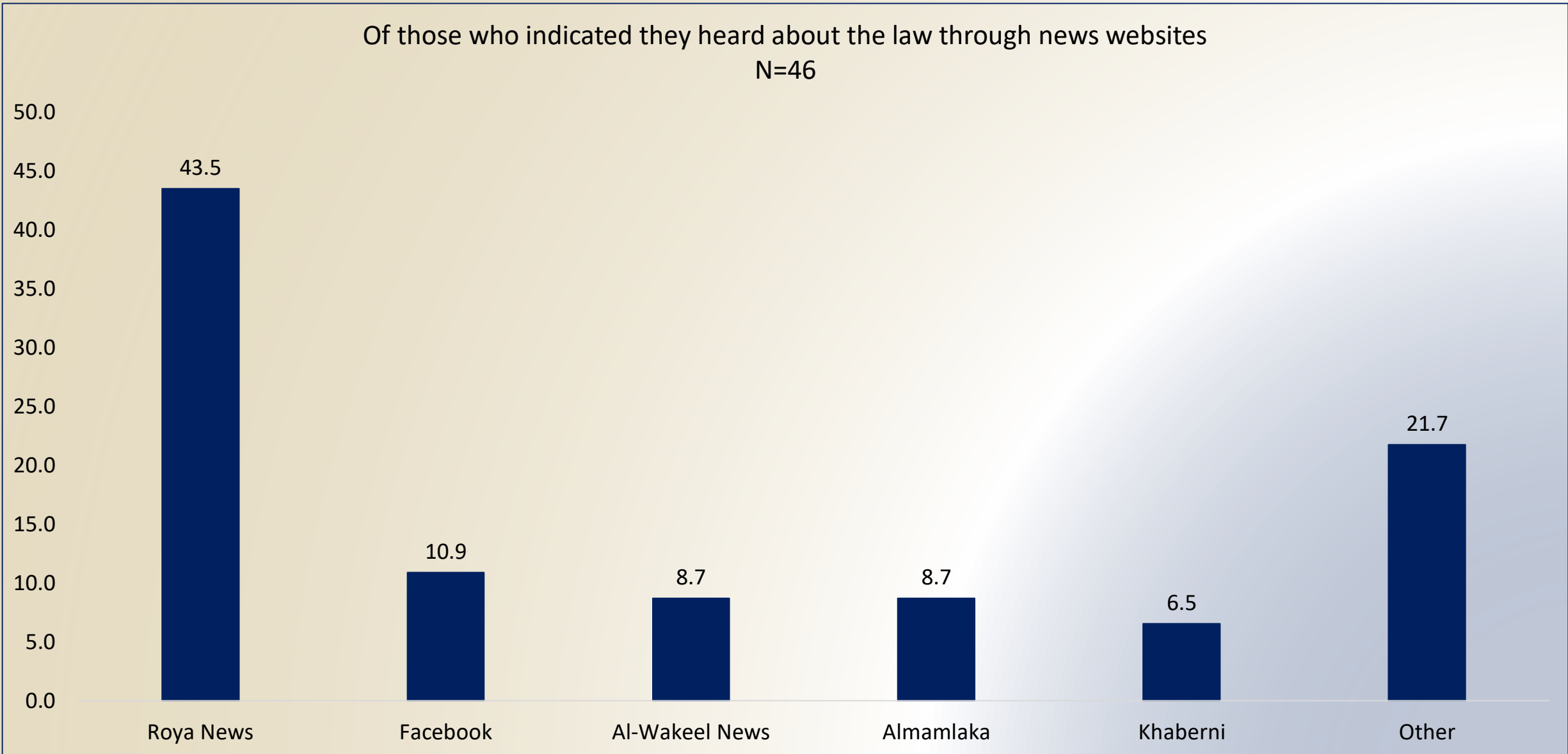
Of those who indicated they heard about the law through Jordanian TV stations

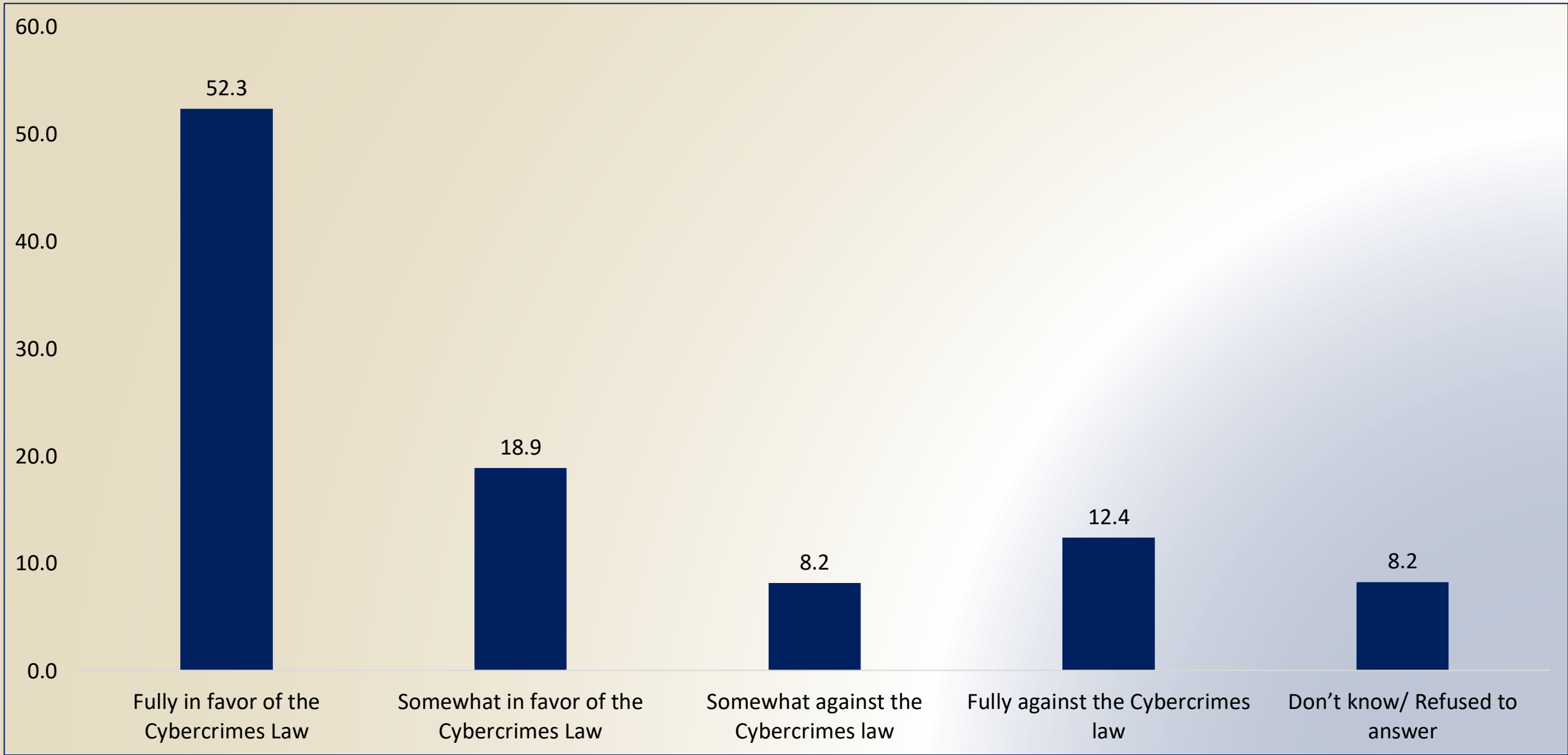


Please name the online news website

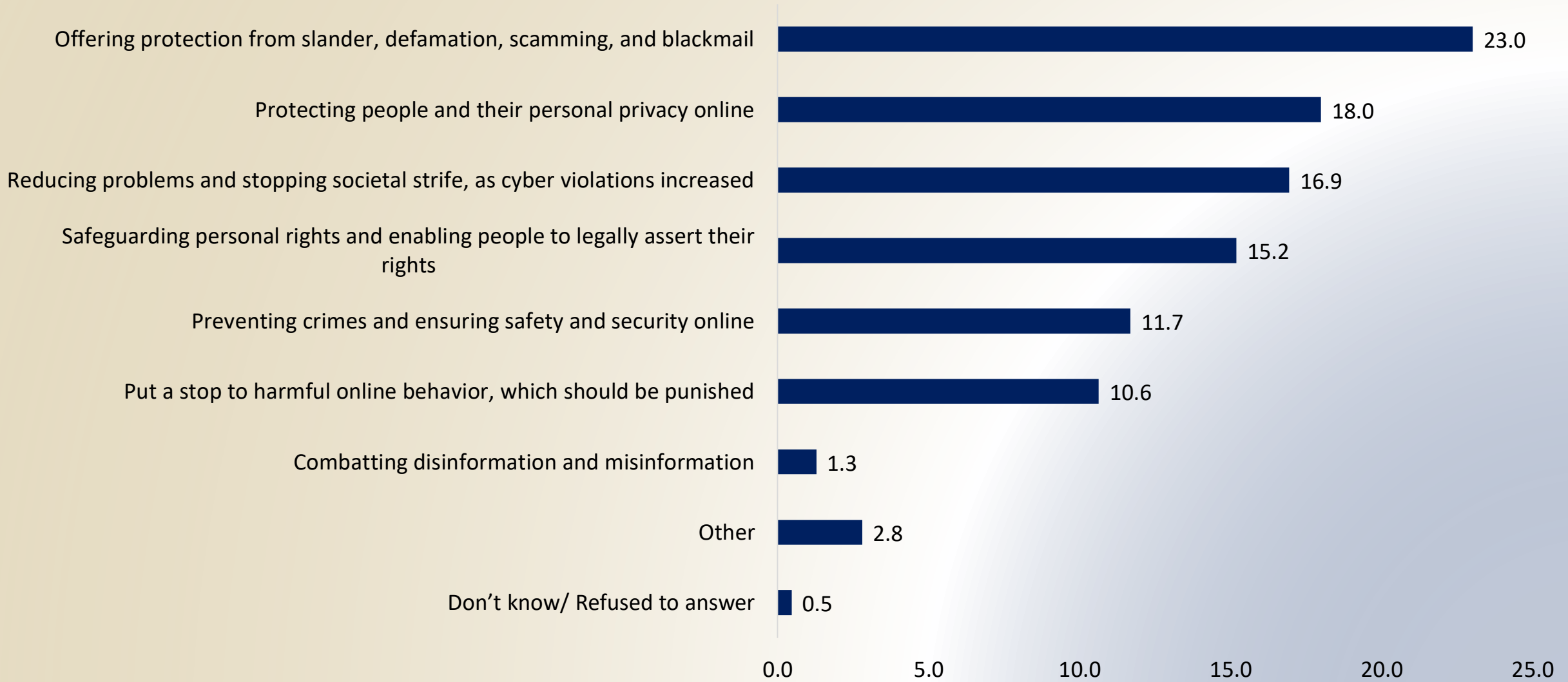

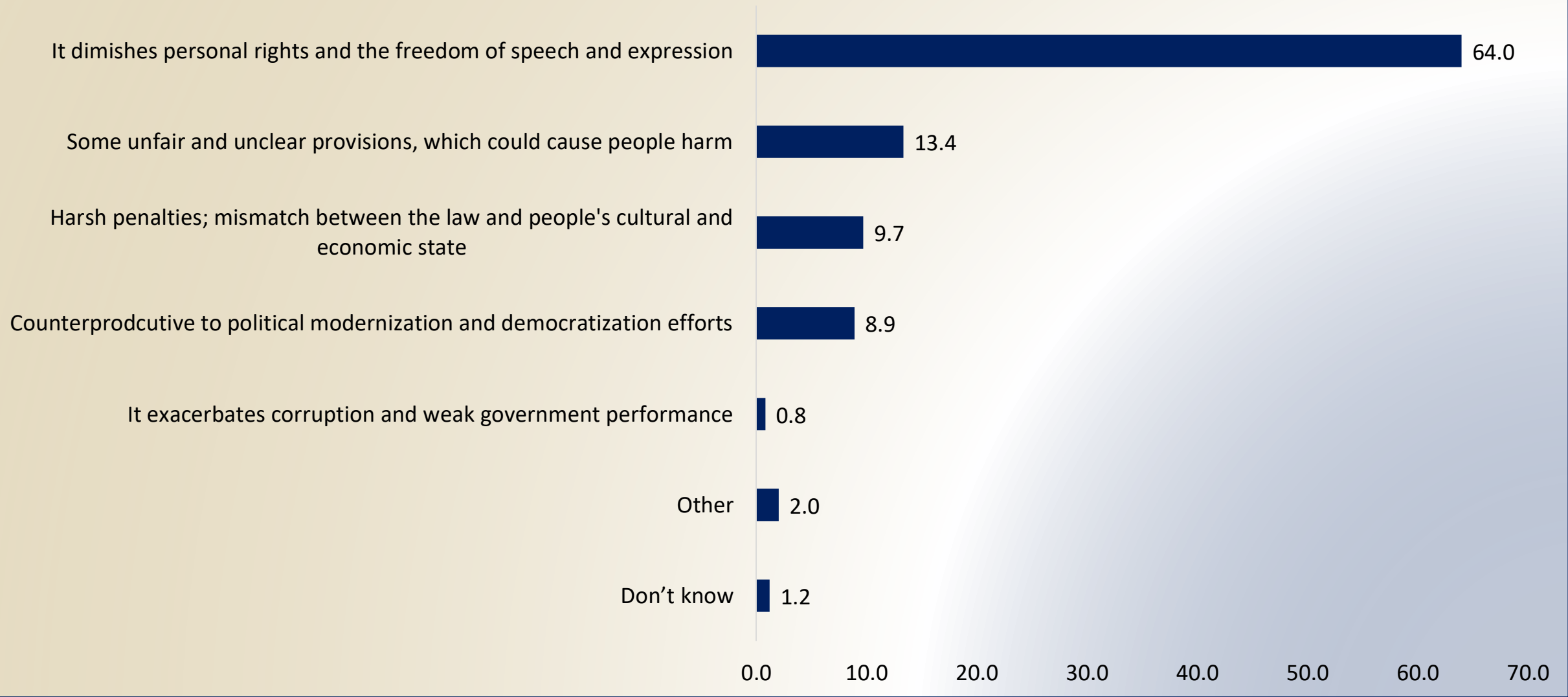
Why in favor?

Of those who indicated they were fully/somewhat in favor of the law (n=856)

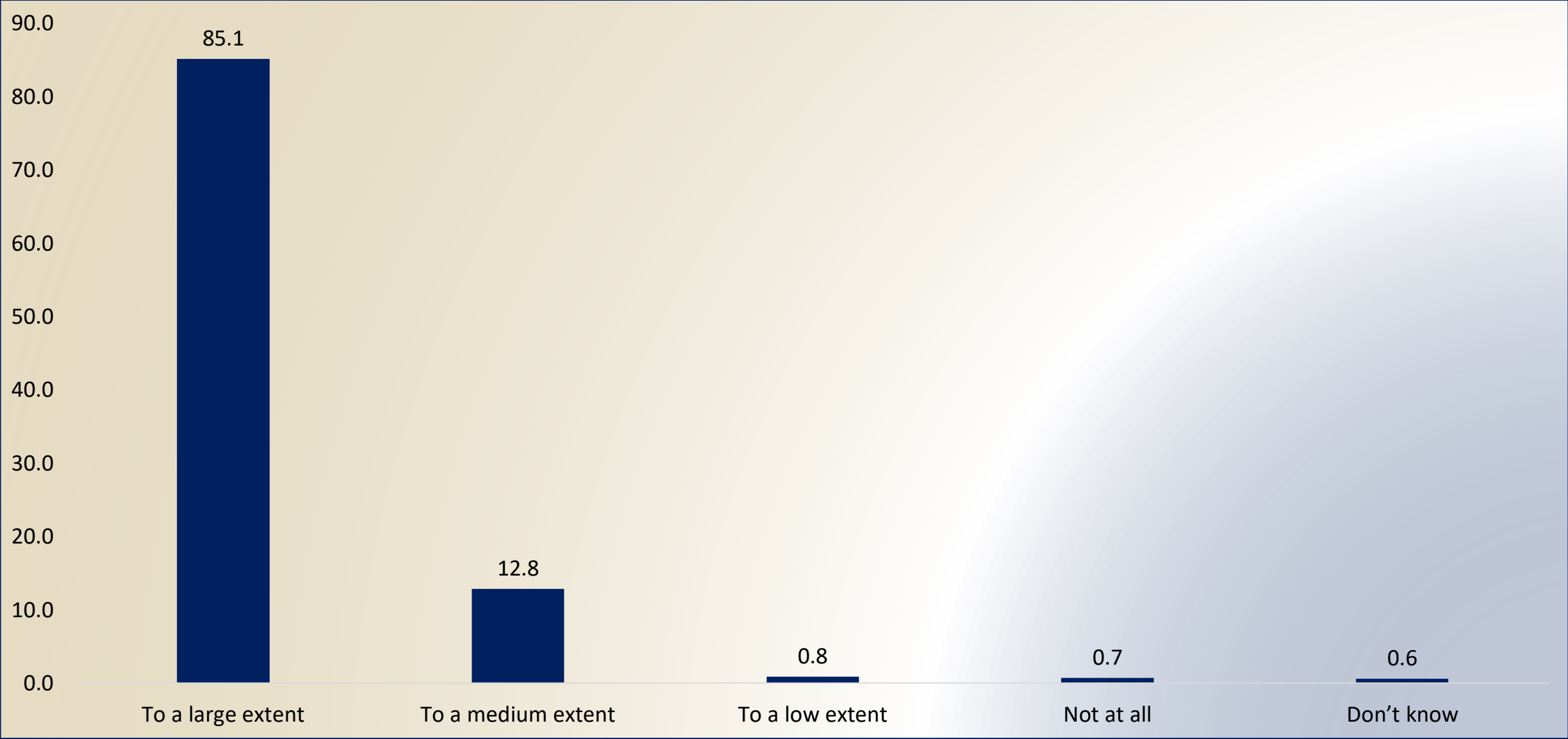


Why against?

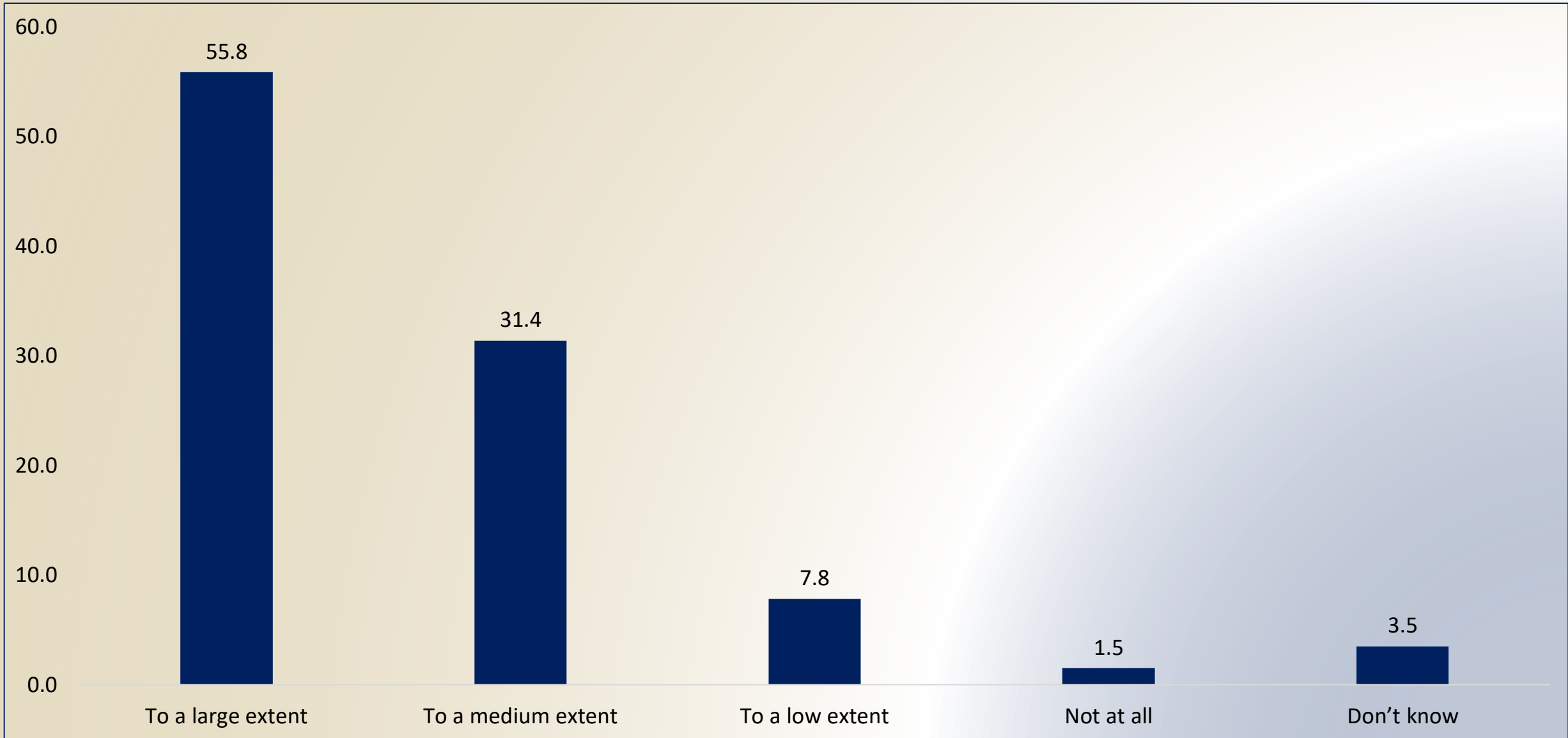
Of those who indicated they were fully/somewhat against the law (n=247)



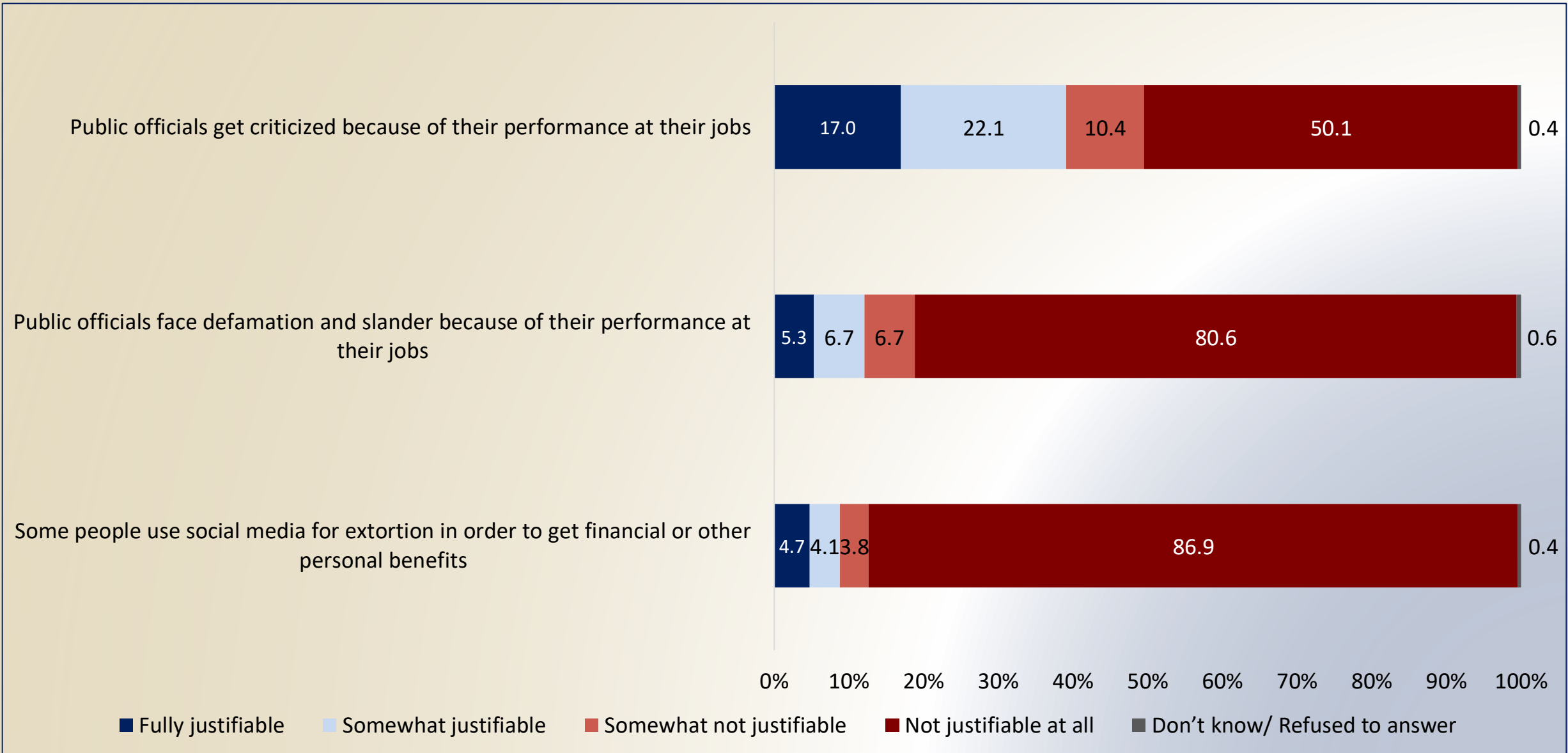
In general, to what extent do you think it is necessary to enact a law that addresses digital issues, such as cyber fraud, defamation, cyberbullying?



To what extent do you think that people use social media sites to blackmail others for financial or other personal gains?

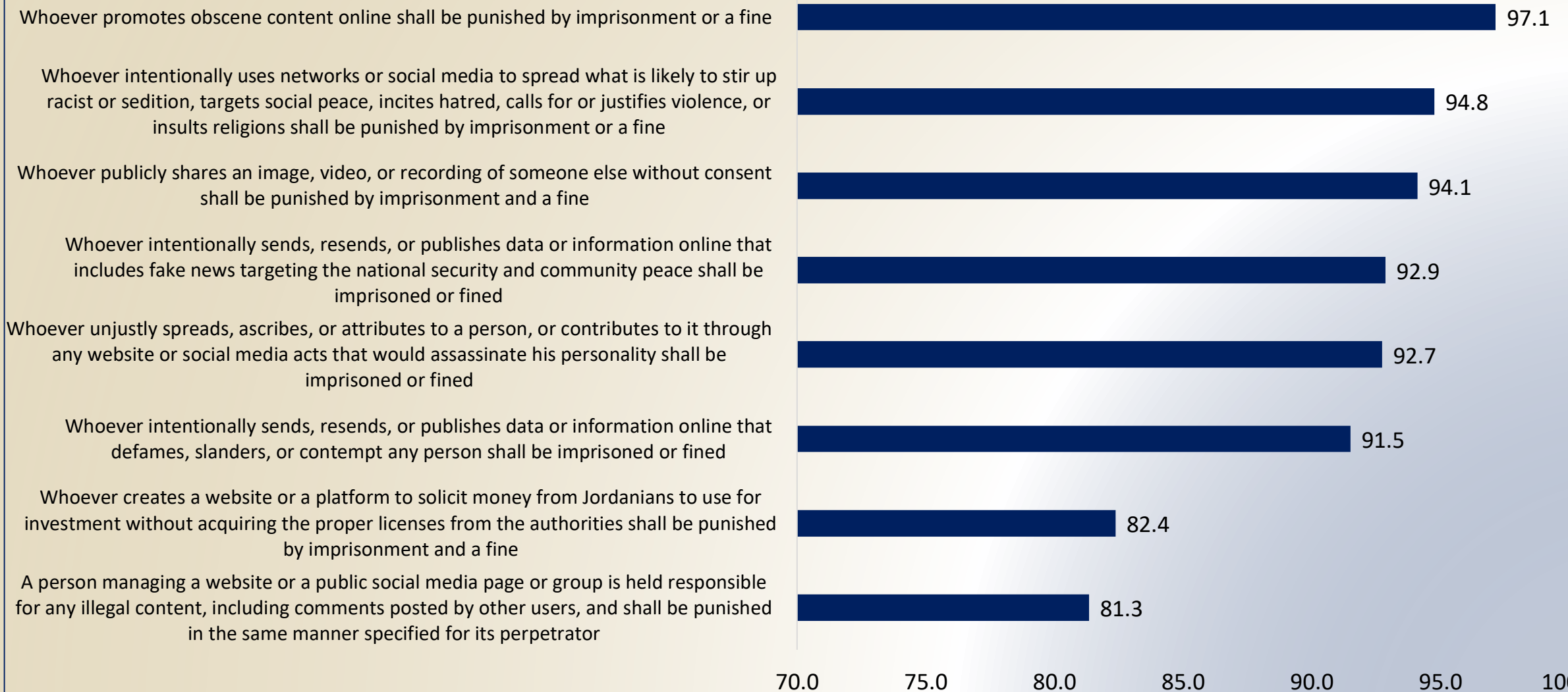


To what extent do you think each of the following is justifiable?

Mean Scores [higher means higher level of agreement)



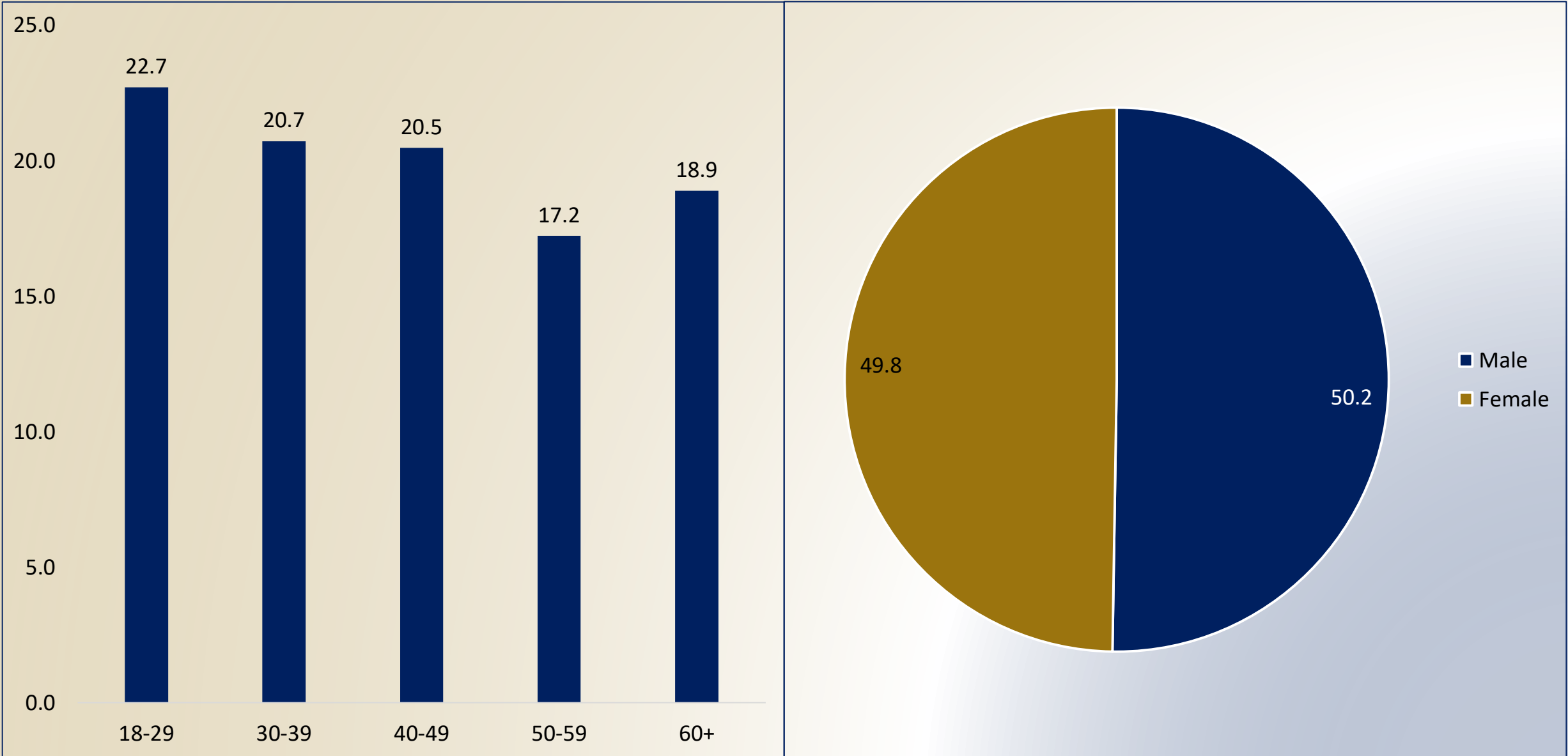

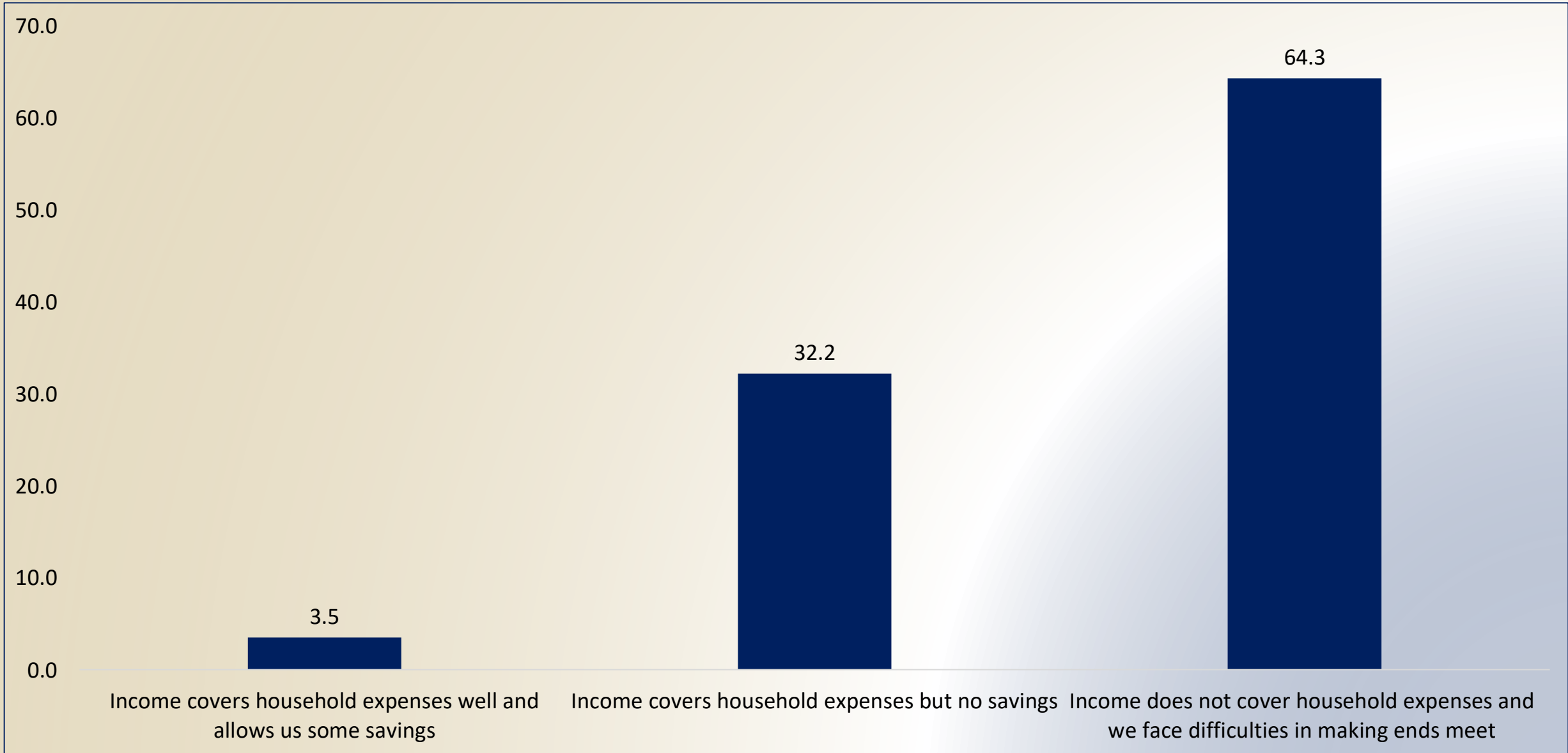
Age and Gender



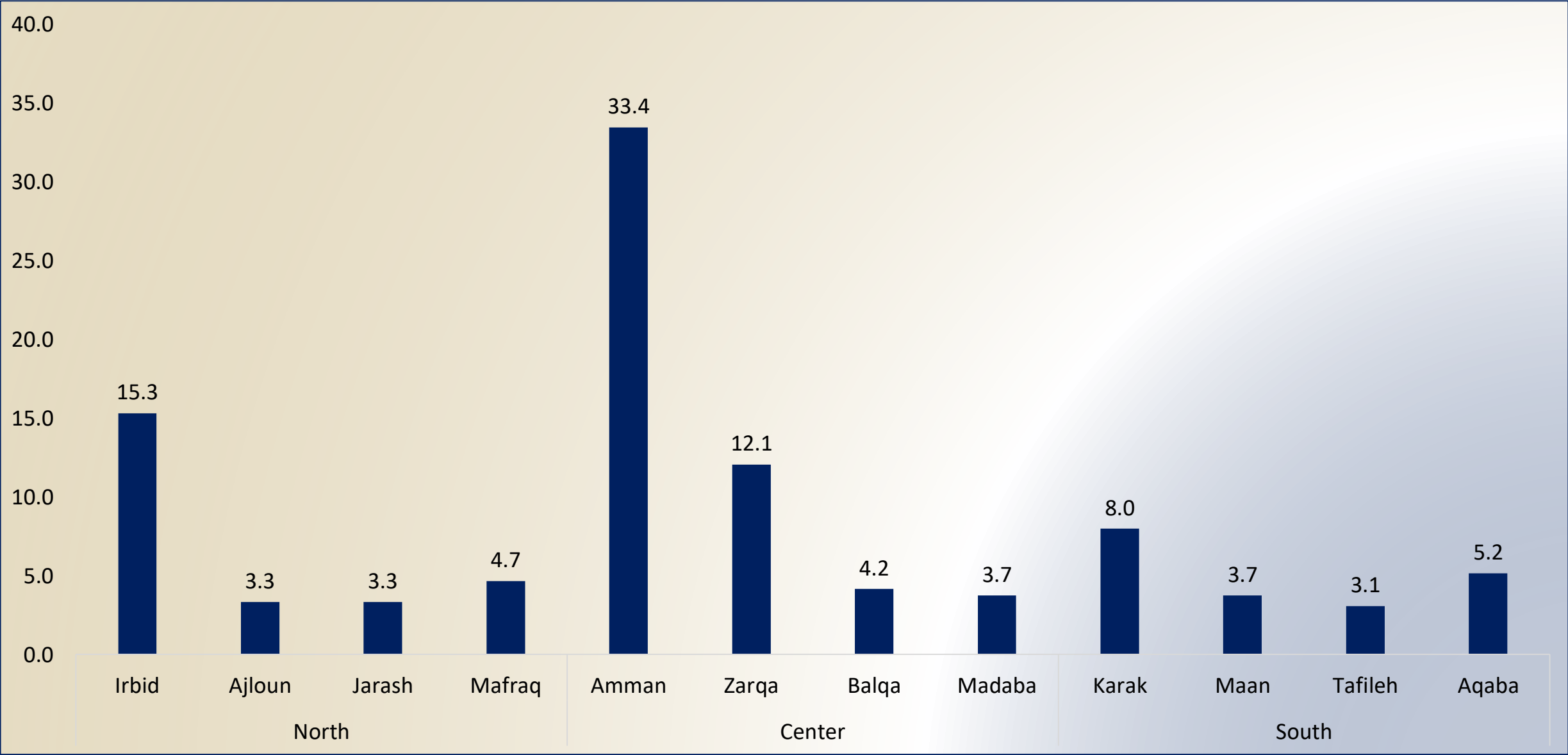
Marital Status and Education Level
